2. Obligations of the parties		

- 2.1. The Organizing Committee under this Agreement free of charge:
- 2.1.1. Issues to the Regional Partner the "Certificate of a Regional Partner" confirming the authority of the Regional Partner at the specified Venue.
- 2.1.2. Provides the Regional Partner with information on events held by the Organizing Committee on a regular basis;
- 2.1.3. Provides organizational and methodological support to the Regional Partner in organizing the Folk Fest (letters to authorities, access to corporate information and advertising products (logo, banners, brochures, company briefs, holiday scripts, etc.).
- 2.2. Regional Partner under this Agreement:
- 2.2.1. Organizes and implement of the Folk Fest at the Venue;
- 2.2.2. On behalf of the Organizing Committee of the Folk Fest, appeals to regional and local authorities with a request for practical assistance in organizing the Folk Fest at the Venue;
- 2.2.3. Carries out the development of a concept, compiling a specific scenario, selecting the venue for the celebration and the personnel involved, delivering information to participants and guests and other organizational tasks;
- 2.2.4. On a regular basis provides the Organizing Committee with information on events held as part of the celebration

## 2.3. Parties to this Agreement:

- 2.3.1. They inform each other about ongoing activities related to the implementation of the subject matter of this Agreement, provide the opportunity for specialists to participate in them in forms agreed by the Parties, organize sponsorship, voluntary contributions, etc.
- 2.3.2. Organize joint events for the exchange of experience, assistance in the implementation of the statutory goals of the Parties.

- 2.3.3. The Parties assist each other in the protection of patents, other exclusive rights and in protecting against unfair competition from third parties.
- 2.3.4. Exchange materials of regulatory, methodological and reference nature.
- 2.3.5 Carry out active advertising and image support of the Parties in the media, the Internet, at Russian and international exhibitions and conferences.
- 2.3.7. Excluded from the exchange, do not seek to receive and distribute materials and information that are confidential and not intended for mass distribution.

## 3. Duration of the Agreement

- 3.1. This Agreement shall enter into force on the day of its signing and shall be valid for a calendar year.
- 3.2. Each of the Parties has the right to terminate the Agreement unilaterally, having previously notified the other Party at least one month in advance.
- 3.3. If none of the Parties terminates the Agreement before the expiration of its validity, the Agreement is automatically extended for the next calendar year.

## 4. Other conditions

- 4.1. The provisions of this Agreement are implemented without mutual financial and property obligations.
- 4.2. The terms of this Agreement may be amended and supplemented by agreement of the Parties and drawn up by the Appendix to this Agreement.
