# ABOUT THE REGIONAL PARTNER OF THE ORGANIZING COMMITTEE OF THE "KOSOVOROTKA DAY" FOLK FEST

These Regulations on the Regional partner of the organizer of "Kosovorotka Day" Folk Fest (hereinafter referred to as the Regional Partner) are developed on the basis of:

- the Charter of "Russian Domostroy" Association and the Charter of "Nexus of Generations" Public Foundation,
- the joint public initiative of the Association and the Foundation "On the formation of public support for the introduction of "Kosovorotka Day" Folk Fest (hereinafter referred to as the Public Initiative, Folk Fest), approved on 15.11.2019 during the joint meeting of the Association and Foundation Boards,
- as well as the Concept of celebrating of "Kosovorotka Day" Folk Fest, approved on November
   15, 2019 during a joint meeting of the Association's Boards and the Foundation.

The Organizing Committee of "Kosovorotka Day" Folk Fest, was formed and approved during a joint meeting of the Boards of the Association and the Foundation, 21.02.2020 in accordance with the "Regulations on the Organizing Committee of "Kosovorotka Day" Folk Fest (hereinafter referred to as the Organizing Committee),

#### Article 1. The subject of regulation of this Regulation

The Regulation defines the system of interaction between the Regional Partner and the Organizing Committee (hereinafter the Parties) in the process of concluding and implementing Agreements on cooperation (partnership) with enterprises and organizations of various legal forms located on the territory of the Russian Federation and abroad. (Further -Agreement)

# Article 2. Purpose of creating this Regulation

The purpose of cooperation is the formation of a system of interaction and coordination of actions of the Parties during the preparation and conduct of the events of "Kosovorotka Day" Folk Fest in a specific region / region / city / town.

# Article 3. Cooperation of the Parties may be implemented in the following areas:

- 3.1. Interaction for the purpose of organizing and conducting by the Regional Partner with methodological and organizational support of the Organizing Committee of "Kosovorotka Day" Folk Fest within the framework of the Public Initiative in a specific region/city/town;
- 3.2. Appeals to regional and local authorities (legislative and executive) and units of the Russian Orthodox Church with a request to support the Public Initiative and provide practical assistance in organizing the Folk Fest;
- 3.3. Development of a concept and a scenario, selection of a venue and development of the main events of the Folk Fest, use by the Regional Partner of the symbols of the Folk Fest, invitation of honored guests and creative teams and other organizational tasks;
- 3.4. The joint activities of the Organizing Committee with the Regional Partner may be carried out in other areas that do not contradict the current legislation of the Russian Federation.

#### Article 4. Legal basis for cooperation of the Parties

- 4.1. The legal basis for cooperation between the Parties is the Agreement concluded in the manner prescribed by this Regulation.
- 4.2. The initiator of the conclusion of the Agreement may be the Regional Partner and/or the Organizing Committee.
- 4.3. An official application document from the Regional Partner is a corresponding letter addressed to the Chairman of the Organizing Committee.
- 4.4. On behalf of the Organizing Committee, the Agreement is concluded and signed by the Chairman of the Organizing Committee or the Deputy.
- 4.5. According to the results of signing the Agreement, the Organizing Committee issues to the Regional Representative a Certificate of the established form.

# Article 5. Monitoring and evaluation of the results of cooperation.

Monitoring of the results of cooperation with the Regional Partner within the framework of the concluded Agreement is carried out in accordance with the action plan, which is agreed and approved by the Parties to cooperation.

### Section 6. Procedure for the Formation of the Register of Partners

- 6.1. The Organizing Committee maintains a unified Register of Partners, monitors compliance with the expiration dates and excludes duplication of Agreements with partners.
- 6.2. The unified register of partners contains the following data for each partner: full name, abbreviated name, legal address, mailing address, contact information (tel., Fax, e-mail, www), name of the head, position of the head, main activity on OKVED, industry, the responsible person from the partner, the responsible person from the Organizing Committee

# Article 7. Information support.

Information support for the work of the Regional Representative is carried out in the manner determined by the Organizing Committee.

# Article 8. Procedure for amending and supplementing the Regulation

Changes and additions are made to the Regulation by unanimous decision of all members of the Organizing Committee.
